


# MyTournament.info

## PRIVACY STATEMENT



Verheijen Consultancy (hereinafter referred to as 'we'/'us'/'ours') respects the privacy of all visitors and users of this website. We consider the careful handling of personal information to be of great importance. We will process your personal information in accordance with the General Data Protection Regulation (Regulation (EU) 2016/679 of the European Parliament and the Council of 27 April 2016).

We process personal information that you have provided to us yourself, for example for:

- Registering and subscribing as tournament organiser on this website;
- The use of the functionalities of this website, such as setting up and managing tournaments and our accompanying service provision;
- Registering for and receiving newsletters;
- The (now or in the future) writing and publishing of reviews on this website;
- Contacting us by email, for example for questions or problems.

The personal information which you provide to us, is solely processed for the purposes for which you have provided this and further as described in this privacy statement.

If you register on this website, you will need to provide certain personal information in order for us to be able to process the registration. This concerns your login name and email address, as well as your payment information in the event that you have opted to make use of the paid functionalities of this website. The personal information provided by you with the registration are processed by us in order to be able to handle your registration, to be able to identify you and - once your registration is approved - to make it possible for you to set up and manage tournaments.

Using their accounts, registered users can upload team, player and arbiter names when creating tournaments. This tournament information is shared with visitors of this website who are looking for that information. It is also possible that the tournament information, at the behest of the registered user, is disclosed through a website of the registered user or a third party. We are not responsible for the method of processing of personal information on websites of the registered user or third parties with which tournament information is disclosed. After all, such websites are not exploited by us.

If you have expressly registered for receiving newsletters, then we will solely process personal information provided by you in that context to be able to send the requested newsletters to you. You can unsubscribe for further newsletters in the method indicated in the concerning messages.

If you write a review on the website, now or in the future, then the personal information provided by you in that context is solely used in order to be able to publish the review on the website.

Abovementioned processing of personal information is permitted by law by virtue of the fact that you have given implicit or explicit permission for this, or on the basis that the processing is necessary to execute an agreement concluded between you and us or for your request to conclude such an agreement.

In the context of the performance of an agreement concluded between you and us, the personal information provided by you can be shared with third parties who are involved in the performance of the concerning agreement, such as an online payment provider who takes care of handling your payment on this website.


In addition, we process personal information if and to the extent that this is necessary pursuant to a legal provision or judicial order, as well as on the so-called legal basis 'justified interests'. Justified interests include, for example, tracking down (attempts to) unlawful and/or criminal acts directed towards us or third parties. Also included under justified interests is the processing (also meant to be understood the saving) of your personal information by our hosting provider, in order to be able to exploit this website and our email services, the (future) operator of the review software used by us in order to be able to disclose your review and the sharing of your personal information with an accounting office in order to be able to take care of our administration and accounting, the latter if you make use of the paid functionalities of this website.

Whenever you visit this website we collect your location information so that we are able to report for ourselves from which country this website is visited and/or tournament information looked at. This allows us to see for each country to what degree the website is visited and used there. When collecting location information, we process IP addresses in an anonymous form so that specific location information cannot lead to you as a person specifically.

Under no circumstance will we sell your personal information. The people who fall under our responsibility, as well as third parties hired by us are obligated to respect the confidentiality of your personal information. To the extent that we outsource the processing of personal information to a third party, we will take the necessary steps to guarantee that your personal information is sufficiently protected. Such steps include, if and to the extent that this is required according to the law, using a processing agreement with such recipients in order to ensure that they take the same or similar technical and organisational measures as we do, so that your personal information is sufficiently protected.

## PRIVACY STATEMENT



### Your rights

You have the right to request perusal, deletion and rectification of your personal information, as well as to limit the processing that concerns you. Furthermore, you have the right to object to the processing and you have a right to data portability. This means that you can submit a request with us to send your personal information which we process to you or an organisation specified by you in a computer file.

To the extent that the processing of personal information is based on the permission acquired by you, you have the right to withdraw this permission at all times, without this affecting the lawfulness of the processing on the basis of the permission prior to its withdrawal.

You have the right to submit a complaint into the Dutch Data Protection Authority or in the event that you are residing or located in a different country than the Netherlands, the supervisory body there. You can send a request for perusal, rectification, deletion, data transfer of your personal information or request to withdraw your permission or objection against the processing of your personal information to [info@mytournament.info](mailto:info@mytournament.info).

To ensure that you made the request, we request that you send a copy of your proof of identification along with the request. In this copy, make sure your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and the social security number are black. This is to protect your privacy. We will react as soon as possible, but within four weeks, to your request.

### Special and/or sensitive personal information which we process

We do not have the intention to collect information provided by website visitors younger than 16 years old, unless they have permission from their parents or guardian. However, we cannot check whether a visitor is older than 16 years old. We therefore recommend parents/guardians to be involved in the online activities of their children, in order to prevent that children provide personal information to us without permission from their legal representative. If you are convinced that we have received personal information from a minor without that permission, then please contact us at [info@mytournament.info](mailto:info@mytournament.info).

### Automated decision-making

We do not make decisions on the basis of automated processes on matters which can have (considerable) consequences for people. We are talking here about

decisions which are taken by computer programs or systems, without any involvement of a person, such as for example one of our employees.

### Cookies, or similar techniques, which we use

This website only makes use of technical, functional and analytical cookies which do not infringe on your privacy. A cookie is a small text file which is stored on your computer, tablet or smartphone when first visiting this website. The cookies which we use are necessary for the technical functioning of this website and your usability. These ensure that this website functions properly and are used to remember your preferred settings, for example. We can also use them to optimise this website. You can switch off the placement of cookies by adjusting the settings in your internet browser in such a way that it does not save cookies. In addition, you can also remove all information which was saved before using the settings of your browser.

### Saving and securing your personal information

Personal information is only saved by us for as long as this is necessary considering the purposes for which it was acquired. If a registered user removes his account on this website, then we will remove all tournament information saved under it as soon as possible, including personal information contained therein. We take suitable technical and organisational measures in order to protect personal information against loss and any form of unlawful processing. These measures guarantee a suitable level of security, taking into account the state of technical knowledge and the costs of implementation, considering the risks which processing and the nature of the personal information to be protected involve. The measures are also focused on preventing unnecessary processing of personal information.
