**Personal data that we process**

**Verheijen Consultancy** processes your personal data because you use our services and because you provide them to us yourself.

Below you will find an overview of the personal data that we process:

- First and last name, gender, address, telephone number, E-mail address
- Other personal data that you actively provide, for example by creating a profile on this website, in correspondence and by telephone.
- Information about your activities on our website

**Special and/or sensitive personal data that we process**

Our website and/or service does not intend to collect information about website visitors under the age of 16. Unless they have permission from parents or guardian. However, we cannot verify whether a visitor is over 16 years of age. We therefore recommend that parents be involved in their children's online activities in order to prevent the collection of information about children without parental consent. **For what purpose and on what basis do we process personal data?**

**Verheijen Consultancy** processes your personal data for the following purposes:

- Offer you the opportunity to create an account

**Automated decision-making**

**Verheijen Consultancy** does not take decisions on the basis of automated processing on matters that could have (considerable) consequences for individuals. These are decisions that are made by computer programs or systems, without a human being (e.g. an employee of **Verheijen Consultancy**) being among them.

**Verheijen Consultancy** does not store your personal data for longer than is strictly necessary to achieve the goals for which your data are collected. We use the following retention periods for the following (categories) of personal data: until account cancellation.

**Sharing of personal data with third parties**

**Verheijen Consultancy** only provides services to third parties and only if this is necessary for the execution of our agreement with you or to comply with a legal obligation.

### **Cookies, or similar techniques, that we use**

**Verheijen Consultancy** only uses technical and functional cookies. A cookie is a small text file that is stored on your computer, tablet or smartphone during your first visit to this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly and remember, for example, your preferences. It also enables us to optimise our website. You can unsubscribe from cookies by setting your internet browser so that it no longer stores cookies. ### **Viewing, adjusting or deleting data**

You have the right to access, correct or delete your personal data. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number black in this copy. This is to protect your privacy. We will respond to your request as soon as possible, but within four weeks.
